BENEFITS

- An affordable scheme which costs only a small sum for wear and tear.
- Use the same boat regularly without having to hire and collect each time you paddle.
- Try different types of paddling (eg slalom, freestyle, whitewater) before buying your own boat.
- Bring to TLP polo sessions to get extra practice at support strokes and rolling in the lagoon area.

WHAT YOU PAY

- Deposit of £180 for plastic kayak + £20 annual wear and tear fee
- Deposit of £220 for slalom kayak + £80 annual wear and tear fee
- Hire fee of £10 per item: paddle, buoyancy aid, whitewater semi-dry cagoule, helmet (non-returnable)

Notes:

A maximum deposit of £300 per family will be charged for one or more plastic kayaks.

A maximum deposit of £400 per family will be charged for one or more slalom kayaks.

However, the annual wear and tear fee applies to each Kayak and set of Kayak Kit borrowed.

HOW WE ENSURE FAIRNESS, SAFETY AND GOOD CARE OF CLUB KIT

Usage

We want you to use the kit on a regular basis, ideally monthly.

2. Safety

Before you sign up we will check that you have and know how to use roof bars and straps safely.

Please also read the "Kayaking in Safety" guidance notes, which are downloadable from the Club website.

3. Storage

To qualify for the scheme, you must be able to keep the Kayak and Kayak Kit securely and under cover (out of sunlight) as extreme temperatures and sunlight make boats brittle.

4. Care, condition / damage

We ask you to look after the kit carefully and deal with all minor repairs.

At the beginning and end of the loan period the boats will be checked for damage. TCKC has an agreement with Paul Knight of PK Paddlesport in Tandridge (www.pkpaddlesport.co.uk) to check the condition of the loan scheme boats and kit on return, and to carry out any repairs needed. If your loan boat or kit needs a repair, however minor, speak to paul@pkpaddlesport.co.uk or call Paul on 07855248766.

Note: Repair to any damage deemed not to be wear and tear in line with the type of boat or equipment and damage caused by misuse or negligence will be charged to the person signing this contract. PK Paddlesport will have the final say re wear and tear vs. damage.

5. Loss, fire or theft

If for whatever reason you are unable to return the equipment upon demand, you will be required to replace with equivalent kit OR repay the replacement value of boat and kit to the Club. The replacement value is shown on the agreement and may be significantly higher than the deposit.

6. Availability

You have first priority over the use of the boat and kit during the Loan Period. However, if you are not using it, the equipment must be made available to other club members for trips etc. If you are away for more than two weeks, please give the Loan Scheme Organiser advance notice.

7. Lending your loan kit to others

When you lend your club loan kit to others, you must transfer responsibility to the other person by asking them to complete a Single Use Kit Loan form, downloadable from www.tckc.org.uk. By doing this, the Annual Loan Agreement with you and all of its conditions are suspended until the kit is safely returned to you.

Use of your loan kit at competitions and events:

If the Club has requested that loan kit is stored or used at a club-defined site or event for use by multiple paddlers, then the primary loan and all of its conditions are suspended for the duration of the storage and/or event.

8. Period of agreement and early termination

The agreement is for 1 year only.

On an exceptional basis at the Club Committee's discretion, a new agreement may be set up after the first year, and only if other members do not require it.

If a second year loan period is approved, you will make the annual wear and tear payments and sign a new agreement subject to the return all equipment for inspection before signing the paperwork.

The Club Committee may terminate the agreement at any time if the spirit of the loan scheme is not being honoured.
